

Santolina ~ Embryo Programs ~ Selection and Fees

Please initial Embryo Program selected.

1. **Embryo Transfers ~ flush and transplant for transfer into Owner ReCip Mare.**

>>>Donor mare Owner should provide 3 ReCip mares for One Embryo transfer.

- Embryo Flush of donor mare, for transfer into Owner ReCip mare, by Vet, billed \$300
 - Santolina billing includes flush Facility, Equipment, Supplies and Media. \$350
 - If additional embryo harvested, add \$150 per embryo for processing, all prgms.
- Transplant Embryo into Owner's ReCip mare plus ultrasounds by Vet, billed direct. Santolina billing includes transfer Equipment, Supplies and Media billed at \$250

2. **Embryo ~ "Flush" for Transport - to be Shipped Or to Freeze for Storage / see FZ \$650**

- Embryo Flush, for transport, by Vet, half billed direct. \$300
- Santolina billing includes flush Facility, Equipment, Supplies and Media. \$350
- Use of Equitaner, Embryo Packing + Air Freight fee + Courier to Airport to ReCip Facility. \$550
- Embryo Freezing for Storage on site at EqCS. \$500 + Storage \$100 per Embryo per year.

3. **Santolina Recipient Mare > ET Program, with lease/purchase option of ReCip Mare.**

- Veterinarian to bill donor mare Vet flush billed direct to mare owner. \$300 ea
- Santolina to bill donor mare flush Facility, Equipment, Supplies and Media. \$350 ea
- Program deposit paid to Santolina – 60 day entry notice/deposit required. \$2000
- Balance Lease fee for Santolina ET "Pregnant Mare" due at 60 days pregnant. \$3500
- Embryo Transplant Supplies for each transplant of embryo into Program Mare. \$250ea
- Santolina Recipient Mare Program >> Renewal fee for year 2 and on per yr \$800

Program Includes: Program entry Deposit is for a ReCip mare 4 to 16 yrs age and includes the ReCip program mare's pre ET exam ultrasounds & meds. Ownership of lease mare, (Program Mare), is retained by Santolina OR mare is purchase by donor mare owner. Deposit paid, *qualifies* owner for the lease program, for one donor mare, to attempt to produce a pregnancy beyond the 60 day ET transplant Day. Deposit *qualifies* Owner for this breeding season with a renewal fee/yr for additional years of the Santolina ReCip Mare Program if (-ET). Should ReCip mare abort after the 60 day billing payment, Donor mare Owner will get a \$3500 credit for next yr. Program Deposit is non refundable or transferable. Lease Mare Value is \$1500 to \$5000, plus +ET.

"Donor Mare Breeding" On Site or "Received" Transported Semen Breeding

Breeding Coordination fee or Mare handling fee. \$350 per (+) embryo flush or ReCip pregnancy.

Includes mare teasing, Facility use, coordination, assisting vet. IF a Second embryo (same flush) Additional \$150 flush/process fee billed. See Complete fee schedule for all fees associated with mare breeding and ET's.

A.I. semen, Airport courier and container return charges, are billed as additional charges for each breeding, plus Vet Ultrasounds (\$45 Approx) and meds associated with breeding mare.

Stall Mare Care \$25 / day with Hays, Premium Mare Care \$28 / day.
